### **GUIDELINES FOR THE PRESENTATION OF EXTENDED ABSTRACTS**

Extended abstracts may contain figures, tables, formulations, or images. The maximum length of the article will be four pages, including Tables and Figures and References (1500 words). They should be written on letter-size paper (216 x 279 mm) (8.5 inches x 11 inches). With margins of 2.5 from the right, left, top, and bottom.

In order to facilitate the revisions by the reviewers, all lines in the manuscript should be numbered consecutively on the left margin as well as the numbered pages.

TITLE: in English and Spanish (Arial 12 font size, bold), no more than 14 words

Name of the principal author, Name Author A, Name Author B, and Name Author C (Arial 11 font size)

Institution or company of affiliation, address Telephone, email address of the principal author (Arial 10 font size)

**Abstract:** The abstract in English must be presented across the page, and it must have a maximum of 250 words (Arial 12 font size).

Keywords: Provide up to 4 keywords related to the work (Arial 12 font size).

**INTRODUCTION:** This section declares the intention of the work, its background, and its importance and ends with the research objectives (Arial 12 font size). In all the content of the body of the work, the citations are summarized with a number that is the consecutive product of the author's order of appearance within brackets [1].

**MATERIALS AND METHODS**: This section includes the details of the experiment, statistical models, experimental design, and procedures (Arial 12 font size). All materials and methods that have been used in work should be clearly indicated, and subheadings should be used where necessary.

**RESULTS AND DISCUSSION**: The findings achieved in the experiment are reflected, explained, and compared with other results obtained. The FIGURES will be numbered with Arabic numbers (FIGURE 1.), while the TABLES will be with Roman numerals (TABLE I). The FIGURES must be sent in the best possible resolution, between 300 and 600 dpi. (Arial 12 font size)

**CONCLUSIONS**: Highlighting the most outstanding of the findings (Arial 12 font size). Conclude your paper by incorporating your most important finding, as well as future work and perspectives (3-4 lines).

**ACKNOWLEDGMENT**: Only institutions, thanks to people, are not allowed. Thank your research grant, organization, and fellowship (where applicable).

**Conflict of Interest**: There should be no conflicts between the authors.





**REFERENCES**: Total number of references should not exceed 15. Resources that have been presented within [] in the text with numbers should be numbered according to their order in the text. References must be written following the VANCOUVER style following a format according to the type of reference shown below:

# If the reference is an article:

[1] Author/s. Article title. International abbreviation for the magazine. Year; volume (number): initial-end page of the article.

## If the reference is a book:

Title of the book. Edition. Place of publication: Publisher; year.

## If the reference is a chapter of a book:

Author/s of the chapter. Chapter title. In: Director/Coordinator/Editor of the book. Title of the book. Edition. Place of publication: Publisher; year; initial-end page of the chapter.
